THE NET ASSET REDUCTION OF \$6,014,851 REPORTED AT PFC DURING FY2025 REFLECTS THE PLANNED, BOARD-DIRECTED EXECUTION OF A MULTI-YEAR STRATEGIC ASSET OPTIMIZATION INITIATIVE, NOT OPERATING DISTRESS.

STRATEGIC RATIONALE: OVER ITS 130+ YEAR HISTORY, THE CONSOLIDATED CHA ORGANIZATION ACCUMULATED SUBSTANTIAL REAL ESTATE HOLDINGS ORIGINALLY ACQUIRED TO SUPPORT RESIDENTIAL CHILDREN'S CARE. AS THE ORGANIZATION'S SERVICE DELIVERY MODEL HAS EVOLVED TOWARD COMMUNITY-BASED PROGRAMS, MUCH OF THIS LEGACY REAL ESTATE NO LONGER SUPPORTS ACTIVE PROGRAMMING. CONSOLIDATED AUDITED FINANCIAL STATEMENTS, AVAILABLE UPON REQUEST, REFLECT THE TRUE COMBINED FINANCIAL POSITION.

LONG-TERM IMPACT.
